That project aimed to improve the entrepreneurial environment (i.e., global attractiveness of the entrepreneurial habitat) in Turkey. For that reason, a group of experts were invited to study the various factors that contributed to the entrepreneurial capacity in Turkey. I was responsible in this project from figuring out the various key performance indicators for measuring the entrepreneurial capacity of different cities in Turkey and in the World. My team and I have collected data from 17 technoparks, 37 incubation centers, 834 startups and 58 investors in 8 different cities of Turkey, and identified 42 variables facilitating entrepreneurial activity. The results have been presented in March 2018 to the minister of Technology and minister of Industry and to some high-level bureaucrats.
